As a Guardian, Colin McLachlan reported that he had overseen operations and was pleased to report that all was in order, and that the Secretary and Treasurer were carrying out their duties in accordance with rules and regulations of the Fellowship and the Office of the Scottish Charity Regulator (OSCR).

## MATCH SECRETARY'S REPORT

As Match Secretary, Colin McLachlan oversaw a number of games, but indicated that covid had put people off playing, and was hopeful for this coming year, where games at Tulliallan and Langside were to be played. Eddie Nicholson of Bridge of Earn questioned Colin as to why games were not played at the greens of committee members. Since 1990, this suggestion was adopted by the then committee. Colin pointed out that the opening game of the Fellowship will be played at Baillieston and the closing game at Langside – both committee members' clubs. Colin also indicated that certain clubs were still discriminating against women bowlers and women disabled members - ridding misogyny has to be paramount in the modern game of bowls

## **Closure of Office Premises**

The Secretary announced that due to health and safety issues regarding cracks in the fabric of the office rooms together with broken down lifts in the building, the committee felt that it would be better for the Fellowship if the office was closed, and that the Treasurer and Secretary would carry on the work of the Fellowship at their respective homes. The Secretary indicated that the Fellowship charity would save around £6,000 yearly by adopting this measure, and that he sought ratification of this proposal from the membership at the AGM. This was duly accepted unanimously.

# Replacing the annual badge with an annual pen

The Secretary explained that the use of the annual badge was dated, and that views from member clubs indicated that an annual dated pen would be more recognisable than a lapel badge. Though some club members liked an annual dated badge, others felt that the badge had had its day. Bowlers rarely wore blazers where they attached badges, and many threw their badge away, so it was felt that a pen would be more useful, though the Secretary proposed that a limited amount of prepaid badges would still be bought for members who wished one. After much discussion, on a proposal by Eddie Nicholson of Bridge of Earn BC and seconded by Gary Clelland of Buchan Park BC, that an annual pen be given to members. This proposal was passed by 6 FOR and 4 AGAINST with several abstentions.

There being no other business, on behalf of the Members present, Vice-President Colin McLachlan thanked both President Edna Gold and Immediate Past President Gary Clelland for the conduct of the Meeting, to all those who prepared the sandwiches, anniversary cake and tea/coffee as well as the bar staff who kept everyone watered.

President Edna Gold thanked President John Hannah of Baillieston BC for the welcome extended to Fellowship Members, and handed the Club back to him.
